Techniseal® Paint, Tar and Rubber Remover for pavers effectively dissolves paint, tar or bitumen, rubber and chewing gum on pavers, slabs, concrete and masonry.

#### **DIRECTIONS**

#### **BEFORE YOU BEGIN**

- · Wear adequate protective clothing. · ALWAYS TEST on a small hidden area to ensure that result meets your expectations.
- · Surface should, ideally, be warm to the touch.

#### **APPLICATION**

Cover stain generously with Remover and let work for 5 to 10 minutes. Reapply product and, using a small nylon scrub brush such as the Techniseal Stain remover brush (145-910), scrub until stain is dissolved. **DO NOT** let dry; rinse immediately.

NOTE: This product dissolves any sealant; apply a new coat of sealant on stripped surface.
